Sealed bids for FISH LADDER AND CULVERT REPLACEMENT, WILLOW SLOUGH SUTTER BYPASS, FISH PASSAGE IMPROVEMENTS, SACRAMENTO RIVER FLOOD CONTROL PROJECT SUTTER COUNTY, CALIFORNIA, SPECIFICATION NO. 10-05, CONTRACT NO. C51411, will be received by the Department of Water Resources, 1416 Ninth Street, Room 418, Sacramento, California 95814, not later than **2:00 P.M. on THURSDAY, MAY 6, 2010**, at which time they will be publicly opened and read at an announced location in the vicinity of such office.

Bid forms for this work are included in a separate booklet titled BID FORM. Bids will be considered only if submitted for all the work required for the above project. The work is defined in Section 01110 – Summary of Work, and includes but is not limited to the following principal features:

Mobilization and demobilization, 2. Clearing and grubbing, 3. Temporary bridge, which includes: a. Bridge structure, b. Supports, c. Access gate, 4. Temporary fish ladder, which includes: a. Timber structure, b. Miscellaneous metals, c. Connection hardware, 5. Sheet piles, 6. Piles, 7. Dewatering, 8. Demolition including, but not limited to: a. Excavation, b. Removal of two corrugated metal pipe (CMP) culverts, c. Removal of existing Denil fish ladder structure, 9. Earthwork: a. Excavation, b. Compacted backfill, c. Pervious backfill, d. Compacted embankment, 10. Aggregate base, 11. Filter fabric, 12. Articulated concrete block mats, 13. Geogrid, 14. Corrugated metal pipe, 15. Concrete culvert plug, 16. Concrete and reinforcing steel, 17. Steel grating, 18. Miscellaneous metalwork: a. Steel beams, b. Guard rails, c. Fasteners and miscellaneous hardware, 19. Stoplogs, 20. Gates: a. Sluice gates, b. Orifice gates, c. Slide gates, 21. Bollards, and 22. Wood flashboards.

Questions or requests for clarification of the drawings or specifications shall be made in writing at least 10 days before the scheduled opening of bids. Response, if appropriate, will be furnished/sent to all prospective bidders on DWR Planholder's List. A tour or meeting regarding the work site will be scheduled and conducted by the Department. **IT IS RECOMMENDED THAT INTERESTED CONTRACTORS ATTEND THE INSPECTION TRIP.**

The Department encourages bidders to explore certification as a Small Business and/or Disabled Veteran Business Enterprise and to utilize certified Small Business and Disabled Veteran Business Enterprises during the contract term.

Contractor's license classification required for this work: A .

All bidders shall be prequalified by the Department. Bid documents will be furnished only to prequalified bidders who meet the requirements of the State Contract Act and Document 00040 – Prequalification.
