




# NOTICE TO STATE WATER PROJECT CONTRACTORS

SUBJECT: 2003 State Water Project  
Allocation Increase

The Department of Water Resources is increasing the allocation of 2003 State Water Project water for long-term contractors from 1.86 million acre-feet to 2.06 million acre-feet. Based on the recent water supply conditions and an updated snow survey, SWP supplies are projected to meet 50 percent of most SWP contractors' 2003 Table A amounts, which total 4.13 MAF. A table reflecting the new 2003 SWP allocated water is attached.

The Department's new approval considered several factors, including existing storage in SWP conservation reservoirs, SWP operational constraints, and 2003 contractor demands. The Department will continue to evaluate the year's hydrologic and water conditions and may revise allocations when appropriate.
